An issue has arisen and I have taken the liberty of contacting users of Jim Trethway's pedigree database program. As some of you may or may not be aware, a commercial enterprise has been <mining> pedigree information for use on their commercial, site.

John Tamburo of MBFS (their product list includes The Breeders Standard), in order to gather data quickly for a new commercial enterprise, has, by use of a mining robot, harvested well over 35,000 names from my website Keeshonden database. (http://www.keesdog.com)

He is now including this data at his site for use by "customers" that are being charged a monthly fee to use his site and access this data.

Most of us using the Alfirin programs have spent many long years accumulating data and discovered that we now could share this data with our various breeds in the hope that by making this data easily available FREELY to breeders, the data would help promote ethical, responsible, healthy breeding that in the long run would help ensure a healthy future for our breed(s). By making this data FREELY available, breeders are able to look at many breeding combinations and choose a breeding that will produce a healthy litter as well as further the healthy development of their breed within their national breedclubs and AKC/CKC or their National breedclubs guidelines.

As most of us link to other breed specific sites, by use of these programs, potential purchasers of puppies, have a chance to explore bloodlines and learn more about their chosen breeds.

To have many years of dedicated work "stolen", "mined", harvested" by an individual/company for commercial use, feels like

personal vilolation. This individual/company has in a span of a day or two taken many, many years of hard work for his own financial gain.

Apparently, Mr Tamburo and his company have done this with a "clear concience" Mr Tamburo has replied to my requests to please remove this data by saying that :

- (A) All of this data is in the public domain, therefore I have a right to take/use it.
- (B) Since I did not have an extensive disclaimer as well as extensive Meta tags and robot txt files, that he had a legal right to "mine" this data.

Tamburo is an amateur lawyer who fancies himself as the next Perry Mason or Columbo. Just reading the "disclaimer" on his program website is an adventure. - 1)- It is my feeling that in order to promote a healthy future for our breed(s), pedigree data must ALWAYS BE FREELY AVAILABLE.
- 2)- By keeping this data on a FREE website with entries supervised by a dedicated individual or group, the data will in most cases be kept up to date and most important accurate. I know that in my case, rather than just merge data sent to me, I verify each and every name and title/award wherever possible.
- 3)- I strongly suggest that if you do not already have some sort of disclaimer both on your website and as well embedded in the HTML code that you do so immediately.
- 4)- If not already in your HTML code that you at a "Robots" Meta tag as well as put a robots txt file into your top level directory. Information on implementing these procedures can be found at http://www.robotstxt.org/wc/exclusion.html

Jim T.also said that in his next update he will include the meta tag headers.

The above 3 & 4 will not guarantee protection against harvesters like Tamburo, but at least it's a start.

I plan to put an opening page on the keesdog.com site telling users that this is a FREE site dedicated to the ethical and healthy improvement of our breed and will ALWAYS remain FREE.

I will add a paragraph (carefully, factually) documenting what has taken place and that John Tamburo has freely admitted that he/his company "mined" from this site.

I will also add a disclaimer that although much of the data is an exact duplicate, Keesdog.com and myself have no association with the commercial enterprise MBFS or John Tamburo.

I will also ask the question as to why anyone would want to pay a fee to access data that is freely available and in most cases more accurate.

Lastly, I would like to say that the the groups using the Alfirin database programs are dedicated to keeping this information freely available and that FREE pedigree information for various breeds, assembled and maintained by dedicated breed fanciers, may be found at:

I WOULD LIKE YOUR PERMISSION TO LIST YOUR BREED AND A LINK TO YOUR PEDIGREE WEBSITE

Please forgive me if I sound upset and have have rambled on, but as an early user of Jim's program, (5+ years now), I view what John Tamburo is doing as a personal violation as well as a scheme to make money from the efforts of others...

There must be some way that we all can "band together" to stop this "theft" and commercial use of our data...

Additionally, we have entered other information, such as OFA clearances, to these animals, and it is technically impossible to separate this information. You presently have the only Schipperke database on the Internet, and the person who told you that we spidered your site has already contacted an attorney, who has issued an opinion that your site competes with ours. Assuming for argument that is true, there is an antitrust defense to the copying that you cannot "hoard" the data to yourself.

Therefore, we will not remove the data from TBS .NET. In addition, if legal action is brought (since you visited TBS. NET, you have agreed to submit all disputes to arbitration in Chicago per the TBS .NET web site terms of use), we will present a defense and ask for our costs and attorney fees to be reimbursed, plus an exemplary sanction, since the case would be frivolous based on long standing law.

Now, in an effort to assist you, we make you an offer: We offer to host your database for no charge and open a perpetually zero-cost portal, saving you the money you presently spend on a web server. You would be granted zero-cost perpetual access to TBS.NET. Should you accept this offer, it would take five to seven days to set up the front end.

We are not making a profit off "your" data, but rather, we are serving our customers who need accurate data. We are careful about that which we do, and we made triply sure that we violated no law when we obtained that which our customers need.

Please consider our offer and respond accordingly. Best wishes.

The statement that we "stole" data files form a non-public section of the domain is a complete falsehood. We have our own logs to prove the exact manner in which we spidered the site. In alleging that we "hacked" her site, Ms. Henry has now accused me of a criminal act. We have NEVER done this. Ever. Moreover, I am sure that if one were to try to get to her database file, that person would get a 403 (Forbidden) error.

I am sorry if I seem angry, but now I am being accused of computer tampering, which is a crime, and it NEVER happened.

Mr. Tamburo

Since you allege that the data is public data, then it belongs to the public, not 1 private individual or 1 private company.

As such, as I understand the public has a right to keep you from gaining finacially for information which belongs to them.

I have, after contacting a United States senator's office recommended that amongst other things that a class action lawsuit be brought against your company to keep data which was meant to be free for non-commercial use from be commercialized. I have contacted Jim Trethway as well as the users of his database program. There are some pretty clever programmers in that list. All have been advised of your devious hrvesting of data for your own COMMERCIAL use.

They will be asked to post on their pedigree websites, a notice similar to what I intend to put on mine...

To the effect that:

Why pay for pedigrees? The pedigree information on this website has been and always will be available free of charge.

MBFS and John Tamburo have by means of a data harvester, gone into websites and taken data. He is now selling the product of all of our hard work and efforts for his own financial gain.

The above is a true, just statement of documented, provable fact.....

The combined number of hits on all of our sites is close to 100,000 hits per month.

By next week the same notice will appear on many of the larger canine e-mail lists...

John, this is NOT a threat, but if you continue to try and profit by what you have in your e-mail admitted is the work of others, then you leave me no choice.

I have absolutely no desire to interfere with your company or it's efforts to generate income by moral, ethical means. How you treat and deal with your customers is of no concern to me... BUT I ask you for the last time to PLEASE remove the data that you
